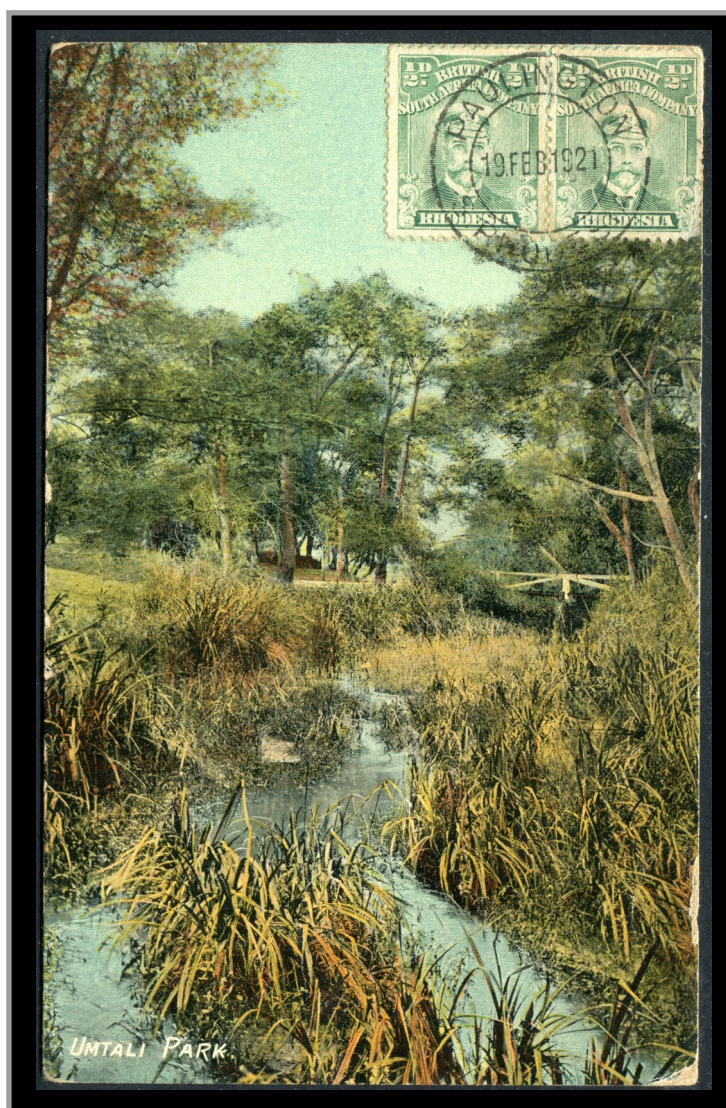


## Multiples of the Greens ( $\frac{1}{2}$ d) and Reds (1d) of the 1913-1925 Rhodesia Admiral Issue

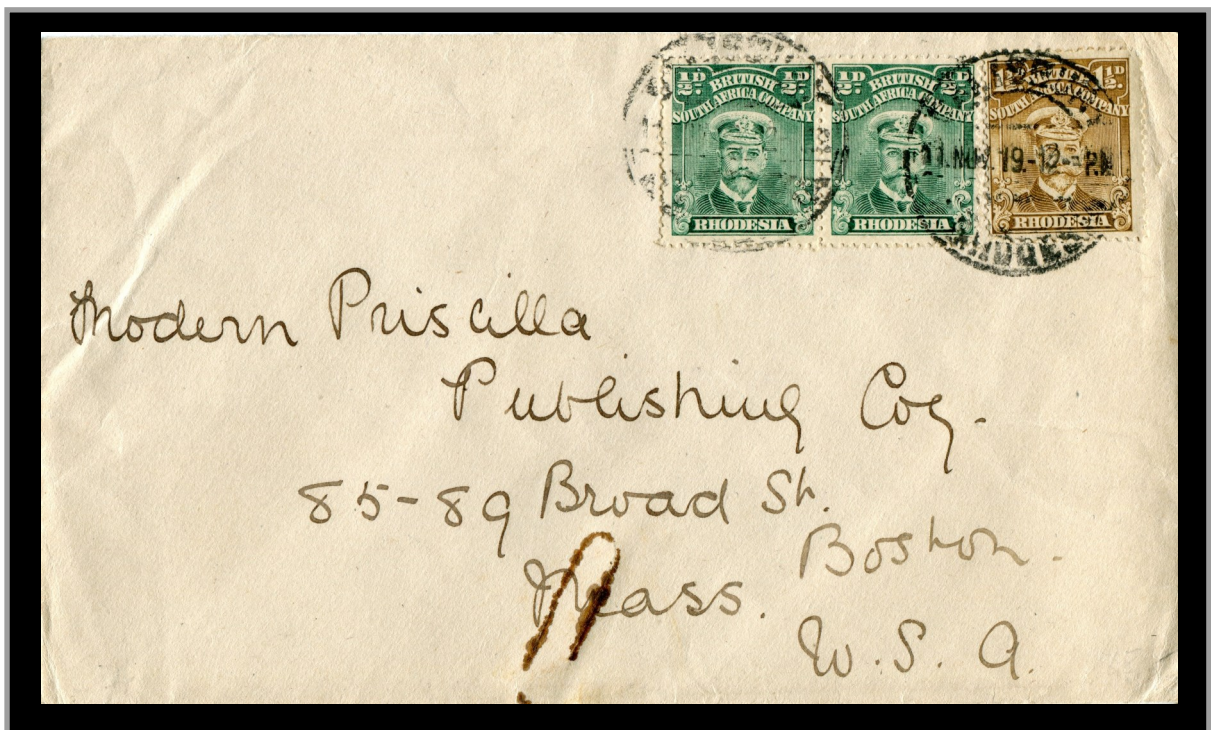
